FOOD VENDOR INFORMATION

- NO LATE APPLICATIONS WILL BE ACCEPTED.
- **Vendors must submit the vendor/ food truck application, food service application, ServSafe certificate, and Allergen certificate in order to be considered. Failure to submit all required documents in a single email will be placed on the waitlist. Please call our office ASAP if you have any special circumstances or questions.**
- Permits to cook and serve food are granted by the City of Cambridge Inspectional Services Department. We will submit forms to the city on your behalf.
- PROPANE: All propane tanks/carts are subject to inspection by a Gas Inspector and Fire Department Inspector. Vendors using propane must pay an additional \$25.00. This fee is non-refundable.
- Food carts must be equipped with fire extinguisher, sneeze guard, cold storage, trash barrels and trash bags at your assigned location.
- All food service vendors will be inspected during the event by the Fire Department and Inspectional Services. Non-compliance will result in removal from the festival.
- Deep-fat frying or open flame barbecue is allowed as long as cooking is completely contained within approved commercial vending carts. Disposing of cooking oil on the street will result in a fine.
